Introduction

We use this privacy policy to disclose the privacy practices of ACUREN's ARES application. We aim to help you understand what data we collect, how we use it, and what control you have over it. This policy applies solely to data collected by our ARES mobility platform.

Who We Are

Acuren is a trusted, single source provider of technology-enabled asset protection solutions used to evaluate the structural integrity of critical energy, industrial and public infrastructures, and to do so we collect and use infield data that we collect on our site.

For the purposes of this policy, we act as the "data controller." We take on this role as we determine how data collected is used and processed.

Data We Collect

- Gathering feedback and opinions on our provided services

How Long We Store Your Data

We will only retain data for the duration necessary to fulfill the purposes for which it was collected is conjunction with services provided. Data may also be retained for longer periods if it is solely for archiving purposes supporting the services Acuren has provided.
